An extraordinary general meeting was held on 14 September 2015 to approve:</p> <p>(i) a placing agreement entered into between the Company and Yim Cheong Share Broking and Placing Investment Company Limited (the “Placing Agent”) on 9 July 2015 (the “Placing Agreement”) whereby the Placing Agent has conditionally agreed to place, on a fully underwritten basis, a total of not less than six placees to subscribe for an aggregate of 2,600,000,000 new ordinary shares of the Company (the “Placing Shares”) at a price of HK\$0.10 per Placing Share (the “Placing Price”).</p> <p>However, as additional time is required for the satisfaction of the relevant conditions precedent in the Placing Agreement, the Company and the Placing Agent entered into the deed of variation to extend the Placing Long Stop Date from 30 September 2015 to 31 October 2015.</p> <p>_____ shares (<i>Note 1</i>)</p>		
<p>(ii) a subscription agreement entered into between the Company and Laberie Holdings Limited (the “Subscriber”) on 9 July 2015 (the “Subscription Agreement”) whereby the Subscriber has conditionally agreed to subscribe for and the Company has conditionally agreed to allot and issue 1,400,000,000 new ordinary shares of the Company at a price equivalent to the Placing Price.
